	• Green Stormwater Infrastructure Walking Tour Join Philadelphia Water Department Outreach Specialist, Dan Schupsky for a walking tour to learn about UPenn's extensive green stormwater infrastructure (GSI) program, including Penn Park, a 14 acre state-of-the- art athletic center that increases the University's green space by 20% and was designed to capture the first inch of rainfall into a 300,000 gallon subsurface detention system. This system will divert 2,000,000 gallons of stormwater from the Schuylkill River each year—about the same amount of water the average American household uses in 20 years! This tour will also visit smaller GSI installations on campus that feature permeable pavers, and rain gardens.
	• Water 101 Workshop Join the WaterNow team and experts in the field for a water crash course designed specifically for elected municipal leaders. This interactive workshop will cover federal and state water law, including stormwater requirements for urban areas, basic hydrology, alternative water sources, and local water financing. Experts will showcase best practices for communicating the value of water to your constituents and share tips for working effectively with utility staff. No questions are bad questions; water is complex, and we'll give you the confidence you need to take the lead on your city's water challenges.



	• Water Infrastructure Finance and Innovation Act (WIFIA) Loans 101 Join the US Environmental Protection Agency Water Infrastructure Finance and Innovation Act (WIFIA) program staff to learn about its long-term, low-cost loans for water infrastructure projects. Participants will learn about the eligibility and statutory requirements, the application process, and financial benefits and flexibilities of WIFIA loans. EPA will share examples from its current borrowers to highlight how WIFIA loans can help communities finance sustainable water management and provide tips to help you be a successful applicant.
